The prospectus

This document constitutes a supplement to CoinShares Digital Securities Limited's base prospectus approved and registered by the Swedish Financial Supervisory Authority (SFSA) on 16 April 2024 (SFSA reg. no. 24-3713) in respect of the programme for the issue of Digital Individual Securities Supplement no. 1 was approved and registered by the SFSA on 16 May 2024 (SFSA reg. no. 24-13647). Supplement no. 2 was approved and registered by the SFSA on 12 September 2024 (SFSA reg. no. 24-24442). Said base prospectus, as amended by the earlier supplements, is referred to below as the Base Prospectus.

This supplement

This supplement forms an integral part of and should be read together with the other parts of the Base Prospectus. This supplement has been prepared by the Issuer pursuant to the provisions of Article 23 of the Prospectus Regulation (EU) 2017/1129. This supplement was approved and registered by the SFSA on 6 February 2025 (SFSA reg. no. 24-33091) and was published by the Issuer on said date.

Reason for this supplement

This supplement has been prepared for the following reasons:

- the Issuer has decided to update and expand the list of Classes of Digital Individual Securities and the list of eligible Digital Currencies in the Base Prospectus; and
- the Issuer is implementing a system for enabling Authorised Participants to make Applications and request Redemptions by means of a secure website and has agreed changes to the Conditions to facilitate such system by means of a supplemental trust instrument.

The changes resulting therefrom are set out in the following pages of this supplement.

Right of withdrawal

Only investors who have already agreed to purchase or subscribe for any Digital Securities offered under the Base Prospectus before this supplement was published shall have the right, exercisable within two working days after the publication of this supplement, to withdraw their acceptances, provided that the circumstances stated above arose or were noted before the closing of the relevant offer or the delivery of the Digital Securities, whichever occurs first. Such investors can exercise their right of withdrawal pursuant to Article 23(2) of the Prospectus Regulation (EU) 2017/1129 during the period from publication of this supplement up to and including 10 February 2025. This right of withdrawal cannot be exercised after said date.

Such investors should contact the relevant financial intermediary through which the investor has purchased or subscribed for the Digital Securities in question should they wish to exercise the right of withdrawal.

SUPPLEMENTAL TRUST INSTRUMENT

By a supplemental trust instrument dated 6 February 2025, the Issuer and the Trustee have agreed certain changes to the Trust Instrument and the Conditions including the creation of 45 additional classes of Digital Securities and certain changes to the Trust Instrument and the Conditions for the purposes of use of the System by Authorised Participants for requesting Redemption of Digital Securities, including:

- adding after the definition of "Subsidiary" in Condition 1.1 the following new definition:
 - "System" means such system as may be made available to Authorised Participants to request the issue and Redemption of Digital Securities via a website operated by or on behalf of the Issuer:':
- adding after the word "must" in Condition 7.5(c) the words and brackets "(save in the case of a Redemption Order)";
- adding after the reference to "Conditions 7.5(a) to 7.5(f)" in Condition 7.7(b) the words and brackets "(as applicable)"; and

 adding certain of the classes of new Digital Securities to the list of Staking Classes in Condition 5.3.

In the sub-section "Management Fee", beginning on page 45 of the Base Prospectus, the information shall be deleted in its entirety and be replaced by the following:

"The Management Fee for each class of Security is an annual rate as specified in the Final Terms applicable to such class.

The rate of the Management Fee in respect of any class or classes of Digital Security may be varied by the Issuer from time to time. If the Management Fee is amended, such amendment will be notified through an RIS, and in the case of an increase will not take effect for at least 30 days following the publication of such notification."

AMENDMENT TO THE SECTION "PART 4 DESCRIPTION OF THE DIGITAL SECURITIES"

In the sub-section "Management Fee", beginning on page 58 of the Base Prospectus, the information shall be deleted in its entirety and be replaced by the following:

The Issuer has implemented a system (the "**System**") for enabling Authorised Participants to make Applications and request Redemptions by means of a secure website and is in the process of agreeing provisions with the Authorised Participants to enable use of such System in substitution for the manual lodging of the forms required by the Authorised Participant Agreements and the Conditions for the purpose of such Applications and Redemptions.

It is expected that, once all the Authorised Participants have agreed to the requite changes to their respective Authorised Participant Agreements, all Applications will be made and all Redemptions will be requested using the System. In the event of a failure in the System, Applications may be made and Redemptions may be requested using the forms and notices described under the headings "Creations" and "Redemptions" above in this section "Creations and Redemptions"."

AMENDMENTS TO THE SECTION "PART 6 TRUST INSTRUMENT AND CONDITIONS"

In the second paragraph of the introductory section of Part 6 (*TRUST INSTRUMENT AND CONDITIONS*) on page 71 of the Base Prospectus, the information shall be deleted in its entirety and be replaced by the following:

Under the terms of the Trust Instrument the Trustee may (subject to certain conditions) delegate all or any of its trusts, rights, powers, authorities, duties and discretions in respect of Digital Securities upon such terms and subject to such conditions and regulations as the Trustee may in the interests of the Security Holders think fit."

The following new definition shall be added after the definition of "Redemption Obligations" in Condition 1.1 on page 81 of the Base Prospectus:

"Redemption Order" means a request to Redeem Digital Securities given by an Authorised Participant through the System in accordance with the relevant Authorised Participant Agreement;'.

The following new definition shall be added after the definition of "Subsidiary" in Condition 1.1 on page 83 of the Base Prospectus:

"System" means such system as may be made available to Authorised Participants to request the issue and Redemption of Digital Securities via a website operated by or on behalf of the Issuer;'.
