This Supplement (the **Supplement**) constitutes a supplementary prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 (the **Prospectus Regulation**) and is prepared in connection with the Programme for Continuous Issuance of Covered Bonds (the **Programme**) established by AB Sveriges Säkerställda Obligationer (publ) (The Swedish Covered Bond Corporation) (the **Issuer**). This Supplement is supplemental to, and should be read in conjunction with, the prospectus relating to the Programme dated 5 April 2024, with registration number 24-8553, that was approved by the Swedish Financial Supervisory Authority (Sw. *Finansinspektionen*) (the **SFSA**) the same date, which comprises a base prospectus for the purposes of the Prospectus Regulation, and the supplementary prospectus dated 17 July 2024, with registration number 24-20253, that was approved by the **SFSA** the same date (together referred to as the **Base Prospectus**). Terms defined in the Base Prospectus have the same meaning when used in this Supplement, and reference is made to the information in the Base Prospectus and to the documents incorporated by reference therein. Any decision to invest in the Covered Bonds must be based on the Supplement and the Base Prospectus taken as a whole and any documents incorporated by reference.

This Supplement has been approved and registered by the SFSA as competent authority under the Prospectus Regulation. The SFSA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. The SFSA's approval should not be considered as an endorsement of the Issuer or of the quality of the Covered Bonds that are subject to this Supplement. Investors should make their own assessment as to the suitability of investing in the Covered Bonds.

# **Purpose of this Supplement**

The purpose of this Supplement is (a) to incorporate by reference the Issuer's unaudited preliminary financial statements for the financial year ended 31 December 2024, including the limited review statement from the auditor thereon (the **2024 Year-end Results**) and (b) to include new statements on trend information and significant changes.

# **Results for Year-end 2024**

On 7 February 2025, the Issuer published its 2024 year-end report, including the 2024 Year-end Results (the **2024** Year-end Report). A copy of the 2024 Year-end Report has been filed with the SFSA and, by virtue of this Supplement, the Year-end Results, are incorporated in, and form part of, the Base Prospectus.

The last paragraph under the heading "Information incorporated by reference" on page 52 of the Base Prospectus shall be deleted and replaced with the following:

With the exception of SCBC's financial statements for 2022 and 2023, SCBC's unaudited interim financial statements for the period 1 January-30 June 2024 and SCBC's unaudited preliminary financial statements for the period 1 January-31 December 2024, no information in this Prospectus has been audited or reviewed by SCBC's auditor.

The following item shall be added to the list of documents under the heading "Documents available" on page 53 of the Base Prospectus:

# Trend information and significant change

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or material inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.
